# REGULATORY CHARGING

#### REGULATORY CHANGES ENSURING FAIRNESS AND COST REFLECTIVITY

- As part of our ongoing commitment to delivering fair and transparent pricing, we have undertaken a comprehensive review of our charges ahead of the 2025/26 charging year. This review is designed to ensure that our pricing is in line with industry standards and Ofwat charging rules.
- We are committed to cost-reflective charges, meaning the price for a particular service or activity is directly linked to the underlying costs incurred in providing that service. This approach ensures that customers pay the costs NWG incurred to carry out the works, and water companies must clearly demonstrate the cost drivers behind their charges.
- Our goal is to offer prices that provide good value for money while accurately reflecting the costs we incur.
- Additionally, we are dedicated to improving the quality of service we offer to all customers.
   This includes further development of our digital platform, which will enhance accessibility and support for all customer types.

#### REGULATORY CHANGES CHANGES TO DEVELOPER CHARGING

- To achieve cost reflectivity, we have aligned our charges with the actual costs of providing our services. We continue to review our charges to ensure we are operating efficiently and promoting competition within the region. In readiness for AMP8, we have refreshed our methodology and foresee increases in our charges.
- To provide transparent costs we're unbundling our charges so that individual elements
  of the charge are displayed. For example, you will see more specific categories of road
  surface in backfill and reinstatement costs, and more detail in your traffic
  management cost breakdown to account for local conditions. This means you may see
  more line items on your quote; however, we are committed to keeping our charges as
  concise and clear as possible.

# INFRASTRUCTURE CHARGES NETWORK REINFORCEMENT AND ENVIRONMENTAL INCENTIVES

#### INFRASTRUCTURE CHARGES CHANGES TO THE INFRASTRUCTURE CHARGE

- We plan to increase our infrastructure charges across the Northumbrian and Essex & Suffolk regions to continue to invest in vital reinforcement work to support ongoing building and developments, in line with OFWAT's charging rules.
- Our network reinforcement costs are forecasted on a 5-year forward looking basis and the charge is calculated separately for each region, with the Essex & Suffolk region in particular requiring significant reinforcement.
- We no longer offer an income offset, however our environmental incentive scheme is in place as a means of receiving a discount against the infrastructure charge. This will be funded by the new environmental component. We will calculate this annually to ensure we are able to fund schemes that incentivise water saving.

#### INFRASTRUCTURE CHARGES ENVIRONMENTAL INCENTIVES

- Ofwat have indicated a move to a **fittings-based** approach for the Environmental incentive scheme instead of the current discounts for meeting certain standards of water efficiency, however this is pending final decision
- We will also support new and innovative approaches to improving water efficiency and it is our intention to encourage developers to meet more ambitious consumption targets

## 2025/26 CHARGES UPCOMING CHANGES

#### UPCOMING CHANGES ENHANCING TRANSPARENCY IN TRAFFIC MANAGEMENT COSTS

- We are committed to providing more detailed and granular traffic management cost breakdowns in our quotations and worked examples. This includes a clear breakdown of costs driven by local authority requirements, safety measures, and other factors such as:
  - •Additional signage: costs for extra signage needed to meet safety or legal standards.
  - •Out-of-hours working: additional costs for carrying out work outside of standard operating hours.
  - •Extra operatives on site: the need for additional staff to ensure safety or compliance with local regulations.
- To ensure that these costs are identified and explained upfront, we have enhanced our quotation process. This includes:
  - •Further training for Estimators: Our estimators have undergone additional training to better identify all relevant costs.
  - •Improved site survey process: We've refined our site survey process to ensure a more comprehensive understanding of the requirements and to capture any hidden or potential costs early.

#### UPCOMING CHANGES BACKFILL & REINSTATEMENT

- We are introducing additional categories for reinstatement to our pricing to better reflect specific local conditions where we are working.
- We're moving from a banded approach to calculating costs based on the exact length of excavation and specific surface types encountered so you'll get a more precise and tailored pricing structure.
- The ability to provide more precise quotes is enabled by enhancements we've made to the site detail card and survey processes. This improvement helps with collecting more accurate data upfront

#### UPCOMING CHANGES COLLABORATION WITH SELF LAY PROVIDERS

- We want to work closely with SLPs to improve the meter installation process through better collaboration aiming to lower costs, reduce inefficiencies and ensure clear communications. To achieve these goals, it will be essential to align on expectations and create a streamlined, transparent process that benefits both parties.
- Key areas we're looking at are;
  - Detailed installation procedures with clear deliverables
  - Reducing abortive visits
  - Improved operational efficiencies
